## **Engine & Cylinder Head Warranty**

The Industrial Injection Service Inc. Engine Warranty covers our Remanufactured Short Block, Long Block Engines and Cylinder Heads. From here on out they will be known as units(s) unless otherwise noted. All remanufactured units are built to exceed factory specifications and carry a 1 Year Unlimited Mileage Warranty.

Industrial Injection Service Inc. warrants the original purchaser of any remanufactured units to be free from defects in materials and workmanship for a period of 1 year for domestic or foreign passenger car or trucks and industrial applications from the date of purchase. This warranty is non-transferable and only applies to the original purchaser. Industrial Injection Service Inc. reserves the right to determine the course of action regarding repair and/or replacement of any and all warrantable units. The purchaser accepts that there will be no refunds for installed or used units in any way. Any refund or compensation for unused units is at the discretion of Industrial Injection Service Inc. and may be accompanied by a 20% restocking fee.

In the event of any warranty claim, the original purchaser must contact Industrial Injection Service Inc. Immediately to notify them of the failure. Purchaser will then be required to fill out and return the Warranty Form which will be provided by fax or email. All warrantable units must include a complete service history, mileage of vehicle at installation and current mileage of vehicle as well as proof of purchase.

After the unit is inspected by Industrial Injection Service Inc. or an authorized dealer to determine the cause of failure to the best of their ability a decision will be made as to the validity of the warranty claim. Industrial Injection Service Inc. will contact and notify the purchaser of their findings and what course of action will be taken.

Warranty will be voided on any unit(s) and Industrial Injection Service Inc. shall be relieved from any and all responsibility or liability under this warranty if cores have not been returned or payment has not been made in full. All bills must be paid, and all cores must returned before Industrial Injection Service Inc. will consider any warranty claims.

All warrantable parts will be provided to the purchaser by Industrial Injection Service Inc. unless otherwise agreed upon. All shop labor rates will be paid via check to the purchaser up to a maximum of \$65.00 per hour based on All Data Labor guide and up to a total maximum of \$2,500.00 per claim unless otherwise agreed upon. No additional costs will be paid for shop materials.

## **Engine & Cylinder Head Warranty**

Purchaser must submit the attached Warranty Registration Form within 30 days and return their core(s) within 60 days of purchase or warranty will be VOID. The 1 year unlimited mileage warranty will be void and not apply to defects or failures caused by abuse, alterations to OEM specs, incorrect installation, incorrect fluids, ran without fluids, ran low on fluids, neglect to regular service intervals, failures related to inadequate tuning, overheating and melting heat tabs, injector or injection pump failure, turbo failure, engine dusting, melted / cracked pistons, valves or cylinder heads from excessive EGT's, thrust bearing failures caused by incorrect transmission alignment or converter "ballooning".

Industrial Injection Service Inc. warranty will expire 1 year to the date of when the purchaser receives the unit(s) as per the tracking number. Any repairs or replacement will not extend the warranty. The purchaser is responsible for all defects thereafter regardless of cause once received.

Joe Gibbs Conventional 15W-50 Break-In Motor Oil MUST be used during the initial 300-500 mile break-in procedure for short and long blocks or warranty will be void. Manufacturer recommended fluids must be used for warranty to apply. Oil and filter must be changed 300-500 miles for initial break in and every 3,000-5,000 miles with records between services for warranty to apply.

Purchaser acknowledges that the unit may require additional parts/accessories to be properly installed.

Industrial Injection Service Inc. will not be held responsible for injury to person or property, lost profits, sales or income, incidental or consequential damages, storage or lodging fees, freight charges, unauthorized repairs, towing charges or roadside assistance.

No salesman, officer, agent or representative of Industrial Injection Service Inc. is authorized to waive or modify this warranty disclaimer and limitation of damages.
